Notice to Municipal Affairs November 9, 2016 that no nominations were received.

MSL:086-16 Hold another By-Election  
Nomination day January 20, 2017  
Only one (1) nomination was received and we needed two (2)

MSL:018-17 Fill two (2) vacancies deferred at general election October 16, 2017.  
August 18, 2017 received resignation of another Councillor (losing quorum).  
Notice to Municipal Affairs August 31, 2017, One council vacancy as of August 18, 2017.

MSL:095/17 Ordering two (2) Councillors a quorum until December 31, 2017 or until new council elected at general election.  
Notice to Municipal Affairs September 25, 2017 three (3) nominations received at general election.

MSL:106/17 Councillors three(3) elected and directed to hold By-election prior to April 2018.  
Nomination day March 26, 2018.  
No nominations were received.

MSL:032/18 Quorum for council is two till 2021 General Election.
